In light of the new Transportation Security Administration's (TSA) Known Shipper program, regulations will be tightened in passenger airline cargo security. Airlines are not able to make funeral homes Known Shippers quickly, if at all; although some are doing the best they can with the limited staff that they have available. It has become an urgent topic of discussion in your industry towards these new challenges in the shipping Human Remains (HR).

Beginning July 1, 2009, in order to fly HR on a passenger aircraft, the *shipper of record* must be a TSA recognized Known Shipper. Mortuaries to date have not been required to be a TSA's Known Shipper and are trying to understand the new security program. The task is enormous considering that all types of cargo are included in these new regulations. After being contacted by several funeral associations, we felt that there needed to be someone who had the compassion and ability to help. The air transportation of a deceased loved one should be the last worry for a grieving family.
